BILL OF SALE - SPAY/NEUTER AGREEMENT - LIMITED HEALTH WARRANTY

Spay/Neuter Policy

All puppies are sold as pets. We make no guarantee that your puppy will have the potential to procreate. Purchaser agrees to spay/neuter the puppy before 1 year of age. Purchaser agrees to supply seller with proof of spay/neuter. If Purchaser fails to spay/neuter this puppy, and provide proof to seller by 1 year of age, ownership will revert to seller who may immediately assume possession of dog. Attorney's fees for recovery will be paid by Purchaser.

72 Hour Limited Well Puppy Health Warranty:

If your puppy is shipped, he/she will be shipped with a Veterinarian issued health certificate. Purchaser is expected to have the puppy checked by a Veterinarian within 72 hours. If your Veterinarian finds a serious communicable canine disease within 72 hours, you have the option of returning your puppy for a PURCHASE PRICE refund. Shipping, and other affiliated costs, are non-refundable. The puppy must be returned before purchase price is refunded. All Veterinarian charges incurred after sale date are Purchaser's responsibility.

1 year Limited Warranty Against Congenital Defect

Your new puppy is guaranteed to be free of verifiable congenital defect including the following for 1 year from date of birth. Hip Dysplasia, Elbow Dysplasia, Patellar Luxation, Autoimmune Thyroiditis, Congenital Heart Disease, Legg-Calve-Perthes Disease, Sebaceous Adenitis, Congenital Deafness, Shoulder OCD, progressive Retinal Atrophy, Von Willebrand's Disease, etc. If your puppy is found to have any congenital defect making him/her unsuitable as a pet, you must supply us, within 7 days of diagnosis, with your veterinarian's written report. We reserve the right to have the diagnosis verified by a veterinarian of our choice before exchange. The puppy would then be replaced with one of the same sex as soon as available. An exchange will be given only upon receipt of puppy (uninjured or harmed), and report from a licensed veterinarian. Breeder is not responsible for any expenses incurred. Any shipping expenses for returning puppy would be at the buyer's expense.

IMPORTANT! PROTECT YOUR PUPPY: Puppies are given a 1st, and if shipped, sometimes a 2nd vaccination. This does NOT mean a puppy is immune to the diseases they are being vaccinated against. Check with your Veterinarian, and follow up with all recommended boosters before taking your puppy in public, taking your puppy to parks, lakes, on camping trips, etc. Your puppy should be taken to the veterinarian in a carrier, and not allowed to roam freely. Do not allow other clients at your Veterinarians office to handle your puppy. They may have a sick pet, and be exposing your puppy to those germs. Never allow your puppy to roam your yard, or home unsupervised. We recommend a crate, or pen, when you are unable to supervise your puppy.

We, the seller, trust that you, the purchaser, have researched all aspects of responsible pet ownership. We, the seller, sincerely want your Puggle puppy to be a wonderful pet. You, the purchaser, must understand that, once your puppy leaves our care, we have no control over where the puppy is taken, or what he/she is exposed to. We make NO guarantees regarding hypo-allergenic properties, shedding, intelligence, temperament, ultimate adult size, or trainability. Purchaser agrees to take full responsibility for any/all shipping, travel, pet supplies, food, and Veterinarian expenses incurred after sale.
